Deposits are non-refundable for any reason other than a physical inability to complete your hunt or death. Deposits can be cash, personal check, money order or credit card. Credit card fees will be applied to all credit card transactions. Outfitter not responsible for cash sent via mail. Deposit amounts: **Antelope-\$1500, Deer and/or combo-\$2500, Turkey-\$1000, Elk or Moose-\$2500, Prairie Dog – 50% of total.**
